Cost Proposal – Construction Materials Testing Stephenson Avenue Improvement Project 2023 Escanaba, Michigan

Project Description

This project consists of existing pavement removal, aggregate base placement and HMA surfacing on 9th Avenue North from Washington Avenue to Stephenson Avenue and Stephenson Avenue from 200 feet south of 9th Avenue North to 17th Avenue North. The entire project is within the city limits of the City of Escanaba.

Scope of Testing Services

Coleman Engineering Company (CEC) has prepared the following Scope of Testing Services based on our knowledge of the proposed construction:

Earthwork and Bituminous Aggregate Base

- Field Testing of earthwork will consist of verifying compaction of in-place subgrade and basecourse. Subgrade sand will be tested in accordance with ASTM D6938 and compared to a maximum density determined by the Michigan One-Point Cone. One site visit of 3 hours is estimated to accommodate soil testing for prepared subgrade and one site visit of 3 hours is estimated to accommodate testing of compacted aggregate basecourse and compared to a maximum density determined by the Michigan One-Point Cone test.
- Laboratory testing of aggregate will consist of one particle size analysis of MDOT 22A Dense Graded Aggregate to confirm compliance with project specifications.
