# **Public Engagement Guidelines**

Escanaba is dedicated to accommodating individuals with disabilities at meetings or hearings. To request auxiliary aids, please inform the City Clerk's Office at least five days prior by writing or calling 906-786-9402.

For those planning to make public comments, we encourage familiarity with the issue. We also suggest that these comments be prepared in advance. Materials related to the meeting will be available at no charge upon request before the session.

When the floor is open for public comments during the agenda item, those who wish to speak should follow these steps:

- 1. Approach the podium.
- 2. Use the microphone provided.
- 3. Clearly state your full name and address for the record, with spelling as needed by staff.
- 4. Direct all comments or questions solely to the Chair.
- 5. Consider the following time limits:
  - Petitioner/aggrieved party: 15 minutes (unless modified by the Chair)
  - General public: 3 minutes (unless modified by the Chair)

The Chair may invite those with similar views to convene and select a spokesperson.
