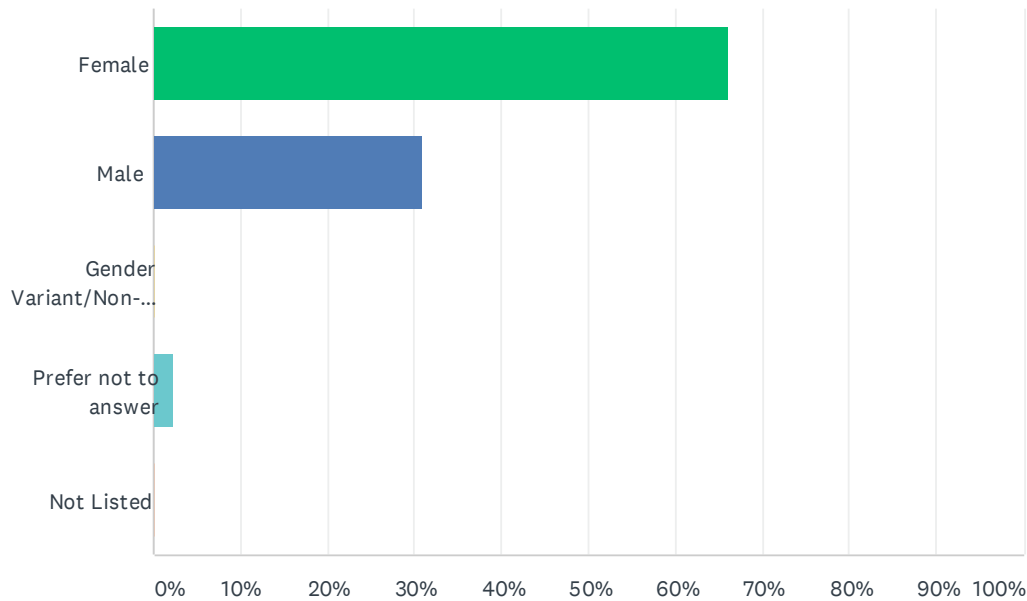

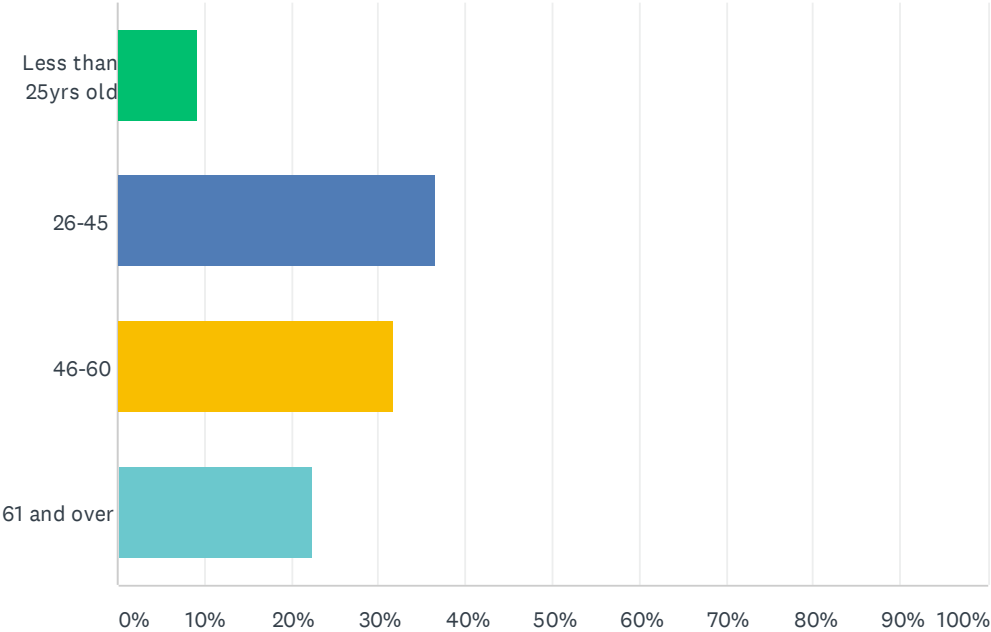

8	The issue/barrier that's stops me from recreating in Escanaba is being approached in extremely frightening ways by men who are complete strangers to me. This has happened a lot (and I mean A LOT) over about the last 10 years. Over that time: Three different men have pulled their vehicles alongside me when I was walking and asked me if I needed a ride. Another man in a vehicle approached me very slowly from behind, drove past, parked on a side street, drove away, then a short time later circled me a couple of times on a city block. Another man leered at for a long time from his vehicle at Ludington Park, then a short time later circled me in another area of the park. Another man approached me very quickly at Ludington Park when I was getting ready to get into my car after walking and said in a very over familiar way, with very pressured speech, that he could "help" me--he seemed to come out of nowhere and I was left with the strong feeling that he'd been watching me. Another two men, each on a different occasion, approached and spoke to me on the sidewalk in very over familiar ways, one of them saying in an excited way that "we" were "going in the same direction"; the other approached me very quickly from behind with such intensity that I heard his shoes against the sidewalk, and when he reached me he started talking to me about items I was carrying as if he knew me very well. Also, every time (and I mean EVERY TIME) I'm walking or bike riding, at least once, but almost always several times, men leers at me from vehicles or when walking/passing on the sidewalk. Again, all of these men are complete strangers to me. And, to say it in very clear terms, in all of these incidents their behavior/view of me was obviously predator/prey. I've spoken with a local healthcare provider and a local cosmetologist about some of these experiences; one said she's experienced very similar things also over a long time, and both have heard the same from other women. Any one of these experiences is very frightening. Experiencing all of them, over such a long time, with seemingly no end in sight is terrorizing. Because of all these experiences it's become impossible to think enjoyment and stress relief when I think of recreating in Escanaba. Instead, I feel grinding and unrelenting harassment, fear, and terror. These are the kinds of experiences that stay with you. They are the kind of experiences that make you think, will the next time be physical assault or sexual assault or being forced into a vehicle and kidnapped and human trafficked? Will the next time be all of these? When walking or biking, I almost always see women with frightened/stressed expressions that I recognize and understand. I can't help but wonder how many other women have/are experiencing the things that I have/am. So, what I would like to change: Escanaba is a nice community and a prime location for so many types of recreation. As you're planning for the present and for the coming 5 years, please know that some women want to recreate in Escanaba, but don't much, or at all, because of the kind of experiences I've told you of here. Also, at every step in your planning please include robust discussion about real and concrete things that can be done to (at least try to) deter things kinds of incidents--sometimes three or four small steps together can make	5/7/2021 9:10 PM

I am unable to make the meeting Tuesday as I have prior engagements but I would love to share some of my thoughts.

The PowerPoint is great and well put together! I will tell you, I have young children and we are active so my input is likely bias towards young families.

I work at the hospital and do a lot of hiring as well. Mostly people from outside our area. Here are some things I highlight when I tour our area and what has drawn people here.

1. A lot of beautiful beach/lake access between Escanaba and Gladstone
2. Great local food
3. Local brewery with dog park
4. Walking trails around the area and even a great new bike/walking path along the lake from Escanaba to Gladstone
5. Lots of great, well-kept parks for children
6. Safe area all around

Some things that could be better

1. Better use of our Ludington park. It is nice that there is so much land but there needs to be local food closer to down there with a nice seating area that will draw people to stop here on boats. Easier to grab a bite to eat and sit on their patio at the lake. So much potential down there that could attract more life.
 - a. Adding a splash pad around this area – on the list to be done, great!
 - b. Adding an outdoor skating rink with lights and a small heating building (could be something like Bark River has)
 - c. I saw that adding a kayak launch to Aronson Island is on the current project list – wonderful!
 - d. Adding electric to the pavilion so it can be better utilized is on the list – again, wonderful!
 - e. Updating the tennis/basketball/volleyball courts down there
 - f. Adding a bocce ball place would be nice but likely not as well used as the above and the money for this could be used for those.
2. Better use of the Marina

I know most of our Escanaba population is older but migratory bird enhancement doesn't normally bring people to the area or is a very big selling point for young families. This could likely steer funds toward other attractions.

I loved seeing the PowerPoint and the amazing work that is being done. I am excited to see our downtown thrive and become more of an attraction, as it should be with all of the beautiful views. I look forward to being on this recreation planning committee.

My comments on the presentation -

First - in general I would like the Recreation Plan to consider two things... 1) Arts and Culture events and activities and 2) Events.

Recreation is about what folks do in their leisure time. Nature is crucial but not exclusive in U.P. recreation. In the Community Input from the survey Art+History were mentioned in the "What do you value about Escanaba's Recreation opportunities?" - and I do understand that they weren't in the top 7 replies). I know art galleries (retail and nonprofit), the library, and museums (like the historical society) are often visitor destinations as well as frequented by residents.

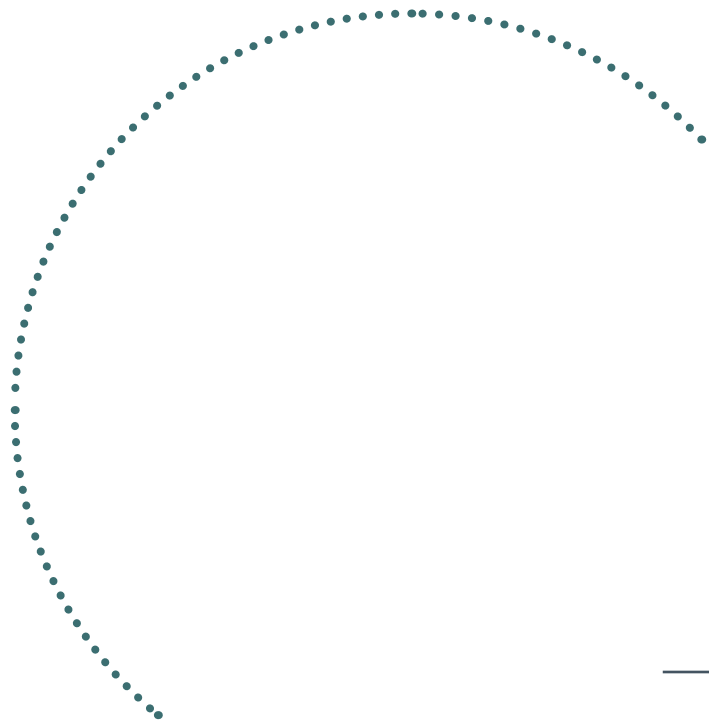
It's clear that Events+Music were the 3rd highest survey response to "What do you think of when someone mentions "recreation". The City sponsors a lot of events/concerts. Music Mondays are "relatively" new but now well established. MarinaFest and Rock the Dock events are popular. The Waterfront Art Festival is a staple in our summer events as is the Cruisin' Classics show. The City Band is a fixture in our community and I think we need to incorporate references to that kind of (already accepted) arts and culture in our Recreation plan. I'd be happy to brainstorm how it gets phrased but I truly think it belongs. Perhaps we should touch on partnerships that we encourage or rely on for these kind of events - like with the Chamber of Commerce, the Marina, and the Bonifas Arts Center as I know the City doesn't control the resources for these events BUT these events DO make the community more attractive as a place to live for young people, to raise a family, and to enjoy one's retirement.

Second - my take on the slides were that they were well done. I like the demographic comparison. Definitely number the slides, pls. Now... to comments about the slides...

- 1) On the community input for "What would you like to change about Escanaba's recreation opportunities?" there was no header/title on the item that scored 33 votes - first slide, top row, middle photo. What was it? And... the photo to its left (Add beach slide +/- or splash pad) - how many votes did it score?
- 2) What does SCORP stand for?
- 3) Give the goal I think that adding arts and culture "activities" and "events" would fit right in ("cultural assets" that "meet the fun, relaxation and health needs..." And in Goal 1 - Host community events... and "Year round recreation opportunities including indoor community assets"
- 4) The Safety slides are great and mostly easy to understand. I want to learn more about how to separate (without a fence) public and private properties.
- 5) The Slide on natural access control sparked a question - are the ramps from Lake Shore Drive to the bottom of Ludington Park generally acceptable? Related questions include would steps be better or would a switchbacked ramp with a grade more amenable to a wheelchair be better? Okay - random. Sorry.

Also, I write grants for the Bonifas Arts Center and I'm willing to help the city write grants to achieve goal 2, "Provide educational opportunities for the community to learn more about the great lakes and local ecosystems"

That's what I came up with. Would love to chat more about this.

ACCESSIBLE TRAILS

- WALKWAYS WITHIN A SITE - minimum 6 foot width and slopes under 2%
- MULTI-USE TRAIL - 8 feet, with slopes under 2%, wider width so two people can walk side by side or people can pass
- REGIONAL TRAIL SYSTEM - at least 10 feet wide, with 1-foot buffers on either side, with slopes under 2%
- SURFACE TREATMENT - unitary surface (ex. concrete, boardwalk or asphalt, crushed aggregate/screenings that have been “stabilized” or natural soils enhanced with soil stabilizers)
- TRANSITIONS - plates between trail and pedestrian bridges, decks, etc.
- INTERSECTIONS - contrasting color treatment and textured surface treatments such as brushed concrete at intersections or interpretive stations to cue people who have vision impairments that there is something to pay attention to at that spot
- close to level cross slopes (side to side) and very gentle running slopes, no steep sections, larger (greater than 60”X60”) level areas at all turns and intersections
- thoughtfully laid out on the site to maximize the experience with minimal difficulty
- AMENITIES - All should be accessible including: benches, restrooms (port-a-johns), drinking fountains, etc.

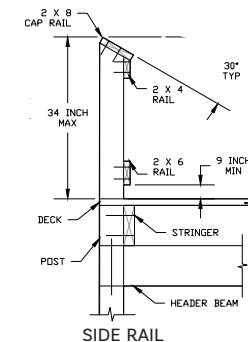

- BEACH**
- routes over the beach and into the water, can be portable/ temporary matting if it needs to be taken in and out for beach cleaning/dragging or in the off season
 - wide enough for side by side walking/passing
 - at beach route end have an accessible area at the waters edge large enough to park multiple chairs while the owners are in the water
 - with a transfer system at the waters edge so people can get down to the ground level and into the water.



TRANSFER STATION



FISHING DOCK + VIEWING DECK

- more than 25% of the rails are lowered in various locations or no rails at all with only an edge treatment to prevent roll off
- sitting benches (all with backs and arm rests) scattered about so anglers can choose to sit or stand to fish
- tackle box stands next to one bench end (not both) leaving one end clear space for sitting side by side with someone in a wheelchair
- a variety of fish landing cutaways strategically placed
- variety of accessible opportunities—over-water fishing, shore fishing, in-water fishing, etc.

- accessible surface on all sites, including rustic sites

CABINS + YURTS

- larger clear space and maneuvering spaces in between all furnishings, including when all are in use (beds, tables/chairs with people seated at the table, shelves within lowered reach ranges, lowered wall hooks, etc.)
- larger clear space thoughtfully located for typical portable items such as coolers, luggage, equipment/food bins/tubs, etc.



CANOE KAYAK OR BOAT LAUNCH

- wider route so someone can hand wheel boat on dolly to launch pulling boat next to them if they are in a wheelchair or two person carry down
- accessible surface to waters edge and into water at launch
- more gentle slopes for easier entry and exit when hand wheeling a boat
- some type of “rack” to stabilize boat at a transferable height then some type of mechanism/roller system to move, while seated in the boat, into the water
- some means of transfer assistance such as overhead bars
- some type of wench system to help pull boat out of water back into the rack to exit/transfer out.
- if there is a dock provide a transfer system on the dock so a person can be seated on the dock to transfer over to a boat in the water that is in some type of a stabilizer rack

- PLAYGROUNDS**
- has both ramp and transfer access to all play components
 - ramps to every “getting on spot” or “sit/stand & do it spot” of every play component
 - transfer system from the ground up to the main deck located near the exits of slides and climbers furthest from the ramp onto the structure
 - only unitary safety surface such as poured-in-place or rubber tiles NOT any loose fill materials likes shredded rubber, wood chips, engineered wood fiber, or any other non-unitary surface material
 - on deck transfer platform at the entry point of every slide
 - on deck transfer platform with one open transfer side and one side with transfer steps to every entry/exit point of every climber, so kids climbing up can get down to the deck to move to another component, as they may have left an assistive device at the ground

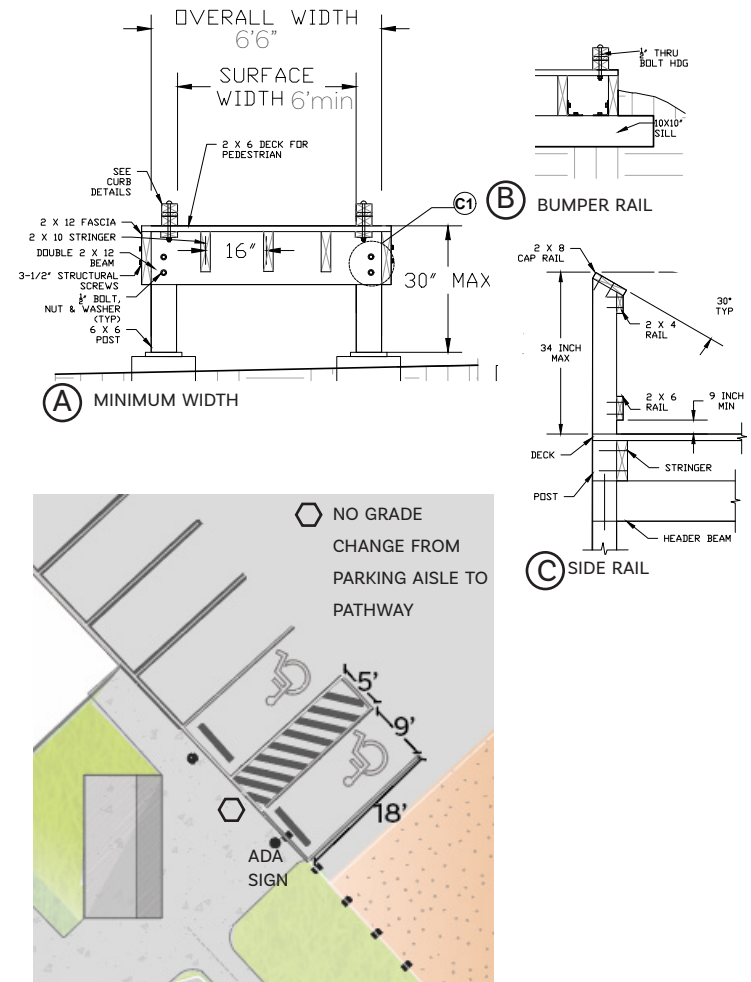

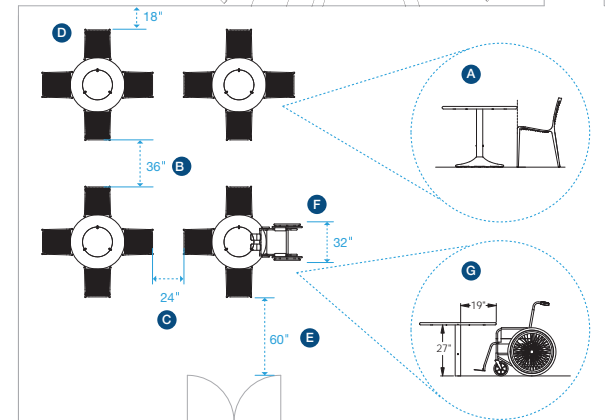
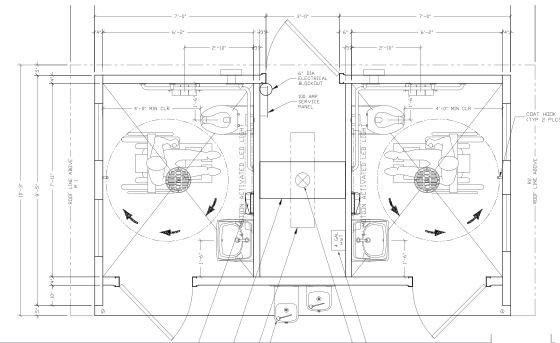

RESTROOMS

- more than the minimum number of accessible units
- multiple unisex/single user toilet rooms/units so opposite sex care givers can assist; also good for parents of young children of the opposite sex so kids aren't sent alone into the multi-user restroom
- thoughtfully located near areas of activity such as play areas, beaches, fishing piers, etc.
- accessible door pulls and water faucet handles
- all accessible port-a-johns, again big enough for individual use or care giver/parental assistance.

PICNIC AREAS + ELEMENTS

- all tables, grills, fire rings, water pumps, etc. accessible
- all located on accessible routes
- level routes onto pavilions with no changes of level from path to pavilion surface
- wider routes and clear space with firm surface around all elements so someone with mobility limits can easily move around the element (table, grill, etc.)
- a variety of table styles, some with clear sitting space on the side, some with extended table tops on the end
- some fixed tables to ensure they remain accessible (not moved off into a grassy or sandy area, etc.)
- clear space all around each element so people can approach and use the grill, fire ring, etc. from the front, back and either side
- grills you can lower/raise the cooking surface with one hand
- raised fire building surfaces so you can place wood without leaning too far over from a standing or seated position



- A. Distances referenced here assume the front edge of a chair lines up with the edge of a table top.
- B. Allow a minimum of 36" between seat backs to permit wheelchair access between tables.
- C. Allow a minimum of 24" between seat backs to provide a walkway between tables.
- D. Allow a minimum of 18" between a seat back and a wall or edge to permit access to all seats.
- E. Allow a minimum of 60" between a seat back and a site's entrance to allow for easy egress.
- F. Please refer to ADA guidelines and local codes to determine the number of wheelchair accessible seating spaces needed in a seating group. It is recommended that a minimum of 32" in width be provided to accommodate a wheelchair at a table.

- Maneuvering space: 60"x60" min and level, at entries and places for change of direction
- Transferable height: 17"-19" with transfer supports
- Knee Clearance: 27" high by 30" wide by 25" deep
- Table tops, counters, and rail heights: max 34" high
- Reach range: 48" max height forward and 15" min low side
- Operation: operating mechanism that is operable with one hand and does not require tight pinch/grasp/wrist twist to open

AL NESS + LEMERAND COMPLEX: 2

The Lemerand Complex features an accessible over 6' wide asphalt path, accessible restrooms, accessible stadium seating. The remainder of the park including Al Ness baseball field, parking, and play area are not accessible as maintained hard surface pathways to the various amenities are not available.



TAPANI FIELD + VETERAN'S PARK: 1

This site contains no accessible features. The street side parking, inaccessible field, playground, tennis courts, horseshoe area, picnic tables and basketball are all surrounded by lawn without accessible connections. This park has been identified as a top priority for updating. The addition of an accessible play space, accessible pathways throughout, and accessible picnic areas would prove excellent upgrades for all.



WEST-SIDE TRAILS: 1

This soft surface trail network and parking area are not accessible due to surfacing, steep grades, and an inaccessible port-a-john. Adding a consistent compacted gravel surface to the parking and trailhead area along with an even graded trail loop would allow for those with mobility issues to enjoy the site as well.



STEPHENSON PARK: 1

This park hosts a small play area, picnic area, and basketball court. All amenities are inaccessible as they do not offer a hard surface path or accessible parking. As with many of the other Escanaba sites. A continuous accessible pathway system would provide a much more inclusive park facility.

LUDINGTON PARK: 3

An expansive park, Ludington hosts many accessible features. There is accessible parking in the marina (3 ADA for 70 spaces), near the band shell (4 ADA for 99 spaces), and on Aronson island (3 ADA for 78 spaces). One additional accessible space is required at the Aronson Island lot. There is a minimum 6' wide paved walking trail connecting nearly all facilities within the park including the fountain, interpretive signage, playground and gazebo. Recently, accessible drinking fountains have been added as well as some accessible play features. The restrooms and band shell seating also meet ADA requirements. A wooden boardwalk is installed at grade down to the municipal beach, but the gaps between the wood slats are too great to be considered an accessible pathway. The playground area at Municipal Beach is also inaccessible due to the edging and material surface. The play structure does have a transfer platform and the concrete circulation on the island passes quite close by so it would not be hard to make the play space more inclusive. Picnic spaces need to be improved providing hard surface trails and accessible tables so everyone can utilize them.



WEBSTER PARK: 3

Webster offers 2 accessible parking spaces signed and striped in a lot with 3 spaces and paths to all facilities. The bath house and wading pool were closed when visited but both appear to be fully accessible.



WEST SIDE PLAYGROUND: 1

An 8' wide concrete path winds through this mini park yet none of the play features or picnic tables can be accessed due to a lack of hard surface access paths leading to them. In addition to hard surface paths to the various play features and surfacing upgrades, the benches on site require a 30x48" hard surface pad adjacent to them to allow for companion seating.



ROYCE PARK: 2

This all season park offers an accessible warming shelter, restrooms and refreshment facility. The courts have 4' wide concrete pathways almost around the entirety of their surface, but a few 4' strips of grass limit who can spectate. The play area and basketball court as well as picnic area are all inaccessible due to grass surrounding

SYLVAN POINT PLAYGROUND: 1

None of this site is accessible from the street side parking to the inaccessible play area and benches. A hardened access path throughout the park with ADA parking would prove a good start to making this site more inclusive.

CATHERINE BONIFAS CIVIC CENTER: 4

The civic center is an indoor athletic and community activity facility. The building and physical access meet all accessibility guidelines from the ADA marked parking spaces to the curb cut with ramp and concrete walkway to the building with a traditional angled aluminum transition plate at the door.

BAY COLLEGE SOCCER FIELDS: 4

The soccer field complex features 5 accessible parking spaces with a lot total of 18. A concrete walk to the concession/picnic facility which is also accessible. A 6' wide compacted gravel trail loops around the fields to provide an accessible trail for those who wish to stay occupied while others are playing soccer.



ESCANABA MARKETPLACE: 4

This new project features an expansive pavilion with paved access on all sides. There is accessible parking, but it is not marked with the International Symbol of Accessibility. A small playground hosts a completely accessible system with an access ramp and accessible artificial turf surfacing throughout.



BESSE PARK: 5

This park is a prime example of an accessible park. There is an adequate number of ADA parking spaces (2 ADA for 22 total spaces), all picnic tables and water fountains are sited on a concrete surface with proper leg room and table height (see universal accessible design guidelines), The play area features a poured in place rubber surface with ramp access and transfer platform. A winding 6' wide concrete path connects all of the elements on the site.



A CLOSER LOOK AT THE ACCESSIBILITY OF PARKS WITHIN THE CITY OF ESCANABA

DICKSON FIELD: 1

Dickson Field is adjacent to the Catherine Bonifas Civic Center. Properly signed, ADA is available at the Bonifas lot, the park would require the addition of an accessible route from parking to field and accessible seating options. None of which are currently available.

DOG PARK: 1

The dog park is located along the entry road to the airport and hosts two fenced in areas surrounded by turf. There are no accessible amenities on site. This site would need accessible parking with an accessible route to the entrance of the park.

ROSE PARK: 1

Rose Park has off street parking that could accommodate ADA signage. There is also a 4' wide sidewalk running through and around the park. Adding a properly graded curb ramp would connect the already accessible features allowing this park to be more inclusive. The play structures are surrounded by mulch and edging that prevent them from being accessible via a wheelchair. The tennis court currently has a sidewalk along one edge and if widened, could accommodate accessible seating space. This site is on the schedule for receiving updates to its court and could be designed to provide improved access for all.



NORTH SHORE BOAT RAMP: 4

The expansive parking lot hosts 213 parking spaces with 8 designated as ADA parking spaces. There is a boardwalk with a flat grade and large fishing platform at the end featuring 50% of the railing at a height of 30in. The fish cleaning station and restrooms have paved access and are properly signed with the International Symbol of Accessibility. The restrooms were not unlocked at the time of observation. The docks are 4' wide and each feature a transition plate with a minimal slope to accommodate those with mobility issues. The docks could use edge protection to prevent wheels from running off. In addition there is not enough space on the dock itself for a person to turn around in a wheelchair (60" diameter).



PORTAGE BAY ACCESS: 1

This site is a simple trail to the water's edge at Portage Bay. It does not provide any accessible options. If the City does plan to make any improvements, an accessible compacted gravel trail with appropriate access to the water's edge would be recommended.
