Sealed Bids for the construction of the Project will be received at the Office of City Clerk located at Escanaba City Hall, 410 Ludington St., Room 101, Escanaba, MI 49829, until March 5, 2024, at 2:00 p.m. local time. At that time the Bids received will be publicly opened and read aloud.

The Project includes the following Work:

The City of Escanaba is soliciting bids for a contractor to conduct exploratory investigations (pothole inspection) of existing water services throughout the City at pre-selected locations, to identify and document the material of the water service. Inspections are completed at/near the curb stop by means of hydro excavating and hand digging, or conventional digging as directed. The inspections are required to meet EGLE minimum service line material verification requirements at points two and three as detailed in the guide document rev. 3/2021 available at https://www.michigan.gov/documents/egle/egle-dwehd-min-service-line-material-verification-req_720143_7.pdf
